4.	Posts sanctioned in Basic Scale 9 to 11.	(i)	Head of Office of in Basic Scale 19 or above, otherwise Regional Head of the Department or if there is no Regional Head, the Head of Attached Department.
		(ii)	DCO concerned.
5.	Posts sanctioned in Basic Scale 12 to 15.	(i)	Regional Head of the Department if in Basic Scale-20, otherwise the Head of the Attached Department if in Basic Scale-20, alternatively the Secretary of the Department concerned.
		(ii)	District/City Nazim concerned.


