NO.SO.II(LGD)2(45)/90: In pursuance of Services General Administration and Coordination Department U.O.No.SO,I(S&GAD)2/7/06(I.G-2) dated 20.1.2006, and with the approval of the Competent Authority i.e. Chief Minister Sindh, Directorate General (Technical) Local Government Department is renamed as Directorate General, Public Health Engineering, Local Government Department. Hence forth the role of Directorate General Public Health Engineering is relocated to perform the functions as under:-

- i. Execution and supervision of all the Provincial ADP schemes, inter-district/inter-taluka schemes, foreign funded projects. The execution of TMA schemes upto 10 million would remain with TMA.
- ii. Provide technical assistance to TMA by PHE, LGD in designing, monitoring and execution of water and sanitation schemes. The PHE, LGD will supervise the operation and maintenance of water supply and drainage schemes of major cities maintained by TMAs.

- iii. TO (I&S) will work under the command of PHE, LGD for execution of PHE, LGD related schemes, other activities of TO (I&S) will remain with TMAs.
- iv. The service record of PHE, LGD staff will be maintained by Directorate General PHE, LGD for their service security and their salaries and other allowances are placed at the disposal of Director General Public Health Engineering Local Government Department for further distribution to TMAs or place of posting.


