





2. The letter mentions that procedure for utilization of user charges is function of respective district government and they will evolve procedure for operation of funds in case of devolved user charges.
3. PSU SDSSP is of the opinion that devolution of user charges to Account # IV, is one component whereas, further authorization of hospital management committees to collect retain and utilize funds collected in account IV for utilization in hospitals require instructions from finance department in order to avoid accounting issues and procedural uniformity across the districts.

It is submitted that Program Support Unit is finalizing agreed third tranche compliance report. Policy action 5 of SDSSP required few actions from government to comply with this tranche condition. The update of policy action and progress made so far is placed below for ready reference:

However, transfer of funds from Account No.IV to the Hospital Management committee account require Finance Department's Authorization/ Administrative order for further transfer of funds as per rules.
